General Description:

This dataset publishes all enrolled providers in the New York State Medicaid program. Section 5006 of the 21st Century Cures Act, requires States to publish a Medicaid fee for service (FFS) provider directory. This will allow consumers with Medicaid FFS coverage to search for potential providers who may be accepting Medicaid patients. The dataset will also enable Medicaid and CHP Managed Care plans to confirm Medicaid FFS provider enrollment, which is required under federal law. Consumers enrolled through a Medicaid Managed Care Plan should refer to their Medicaid Managed Care Plan's directory of participating network providers.

Consumers may use the name, profession, or service and providers specialty to easily search online for individual provider contact information.

Data Methodology:

The data is extracted from the state Medicaid Management Information System (MMIS) and filtered to only include active enrollment status codes with active service locations. It includes the provider's:

Limitations of Use:

In accordance with the Personal Privacy Protection Law (Public Officers Law, Article 6-A), the data posted to the public viewing site does not contain the Social Security number or the date of birth of the providers within the dataset.

The dataset does not indicate whether the listed providers are currently accepting Medicaid fee for service patients. The dataset only indicates that the listed providers are enrolled in good standing with the New York State Medicaid program.

Telephone numbers will only be included in the data when reported by the provider. As of March 1, 2019, all provider enrollment applications must contain a valid telephone number for each service address location submitted on the enrollment application.

Email address will only be included for Private Duty Nurse (PDN) providers. All other provider records will be blank.

Service locations for Category of Service (COS) 0164-Supportive Health Service, 0265-Case Mgmt. Service, and 0464-Doula may not be reflected in the dataset.
